We are pleased to provide the following prices:

- 1. Replace the double hung window in the conference room with a solid insulated panel. Labor \$1,440 Material \$2,380 **Total \$3,820**
- 2. Remove back wall of Judge's area and create a space approximately 10'x6' for additional storage space for Judges. Ceiling will need posts on each end with a header. Floors are at two different levels and will require a step to be built. We plan to use existing floor, ceiling, and the wall to South. Install an additional light to be switched with judge's room and 2 additional electrical outlets. Drain boiler and remove baseboard heat and reconnect as required. No new doors will be needed. Labor \$9,850 Material/Subs \$5,700. **Total \$15,550**
- 3. Replace a 3'0"x 6'8" insulated metal door with 4" x 25" side lite, new closure, hinges, interior kick plate, panic hardware, weather stripping, and threshold in existing door frame going from court room to outside. Reinstall existing coded lock. Labor \$1,930 Material \$2,890 **Total \$4,820**
- 4. Install an approximate 36'x84" solid low E double pane window with Ballistic film from Judge's room to exterior. Labor \$4,770 Material \$5,180 **Total \$9,950**

Above prices include prevailing rate, necessary drywall work, caulking, debris removal, and trucking of materials

Prices are based on more than one project happening at a time to be more labor productive. If not all projects approved than pricing could change a little.

Exclusions: -permits from Village of Mt. Morris

-removal and replacement of existing furniture or lockers

-painting by others

-Tax
