Mayor Mike opened the special meeting and stated there were two things on the agenda transfers for ARPA funds for the parking lot and the purchase of a new police vehicle.

Mayor Mike asked everyone to stand for the pledge.

Mayor Mike stated these transfers should have been done at the regular meeting in October, but he couldn't find them.

Mayor Mike asked if any of the board members heard from Trustee Bryant, Trustee Shea stated that he just texted her and he probably wasn't going to be able to make it.

Mayor Mike asked Chief Brado to present the quote he found for a new police vehicle.

Trustee Manthey- asked Clerk/Treasurer to add this to the minutes:

Trustee Manthey advised we were talking about the purchase of a car and funds be use at the time. We were in the middle of a motion of purchasing a new police vehicle when advised by clerk Torcello still could apply all ARPA funds to water project which mayor Mike advised we were discussing the motion of a car purchase and not the water project right now. The mayor advised his input on the financial status of the village that we are in a good position at the time based on current reports. Trustee Manthey advised that has been budgeted this year, it was removed through motions/resolutions of board members. Additionally, the was previously approved by the board budgeting through ARPA funds of 40k equipment and 10k police contractual. Also advised that it was requested to the chief at the prior meeting to get a quote for a ford explorer by other board members since they rather have that a ford vs the dodge. Trustee Manthey advised if we had no intentions of moving forward then why we were here for a special meeting and waste the time of a meeting while having the chief research guotes if we have no intentions of the chief request. Trustee Manthey advised a car run 17-18 hours a day and will break down, we have a vehicle that has several miles and repairs that needs to be replaced. Did reference that a purchase was made to piece of equipment, 49k that we have only spend \$1900 in rentals over the past years ( did not reference anything about where it was out of during motion discussion, but advised that we need to be smart about purchases for all department heads and put them in a position to have resources to success in the job). Additionally, advised we have the ability to do at that time, otherwise we are have to figure out the expense potentially in next year budget and potentially other boards in the future where this items would not need to be addressed in the next couple years.

Chief Brado stated he found a 2025 Police Interceptor. in the amount of \$50,499.00. Mayor Mike stated that it is a good price and that the funds should come out of the ARPA funds. Discussion regarding the purchase of this vehicle. Mayor Mike stated this is public safety and it is needed. Trustee Shea asked if they only had \$20,000 left in the ARPA funds after the parking lot transfers where the rest of the funds would come funds. Clerk/Treasurer Torcello that it would have to be transferred from police contractual, street equipment, culture & recreation, youth contractual, street contractual, mis. Home & comm. And even water or sewer.

Mayor Mike stated that the rest of ARPA funds needed to be spent by 12-31-2024. Clerk/Treasurer Torcello stated that the remaining \$88,780,00 ARPA funds could be put toward the water project because that is under contract or any other project. Trustee Manthey stated that each of the ARPA funds were divided up and the police department was giving this money and should be able to put it toward a police vehicle, just like Superintendent Young received a new piece of equipment. Clerk/Treasurer Torcello stated to Trustee Manthey that Superintendent vehicle came out of the CHIPS program. Mayor Mike stated that this wasn't costing the taxpayer anything and the village is financially fine, or he wouldn't have suggested this.

Trustee Manthey wanted to know if the board didn't want Chief Brado to get quotes and bring them back to the board, they were all here on a Wednesday night wasting everyone's time.

Mayor Mike stated that he always takes the advice of his department heads, and he will be taking the advice of Chief Brado for the purchase of this vehicle.

Mayor Mike stated we have the money we should spend on it. The clerk/Treasurer asked what is going to happen in a few years when the village needs another vehicle and there are no more ARPA funds, he stated we will cross that bridge when it comes.
